City of Manassas Park	Funding for this project would go toward replacing legacy access camera systems throughout four Manassas Park City buildings and install security/surveillance cameras at nine significant high-traffic intersections in the City.	City of Manassas Park VA	\$447
Friends of the Portsmouth Juvenile Court, Inc.	Funding for this project would go toward implementing a Group Violence Intervention Program in Portsmouth, Virginia, to address conditions that encourage participation and perpetuation of community violence.	City of Portsmouth VA	\$198
Virginia Commonwealth University	Funding to establish a holistic, effective, evidence-based, and sustainable Gun Violence Prevention/Intervention Framework, or Model, that will serve as a public health response to the underlying social, economic, and systemic factors that promote gun violence within the City of Richmond. Virginia Hospital & Healthcare Association Foundat	Funding for this project would go toward hospital-based violence intervention programs (HVIPs) that provide personal advocacy, emotional support, and wraparound services to survivors of sexual and domestic violence.	City of Richmond VA	\$488
City of Suffolk	Funding for this project would be used to replace Suffolk's outdated Computer-Aided Dispatching (CAD) system in the City's Emergency Communication Center and the Police Records Management System (RMS) in the Suffolk Police Department's Records Management Center. The current CAD system was installed in 2001, which is a security deficiency.	City of Suffolk VA	\$3,492
George Mason University	This project would take steps to train law enforcement officers and departments in productive handling of incidents involving individuals with mental health disorders, in concert with local communities and professional mental health crisis intervention managers.	Fairfax County VA	\$1,483
Opportunities, Alternatives, and Resources (OAR)	Funding for this project would go toward supporting a diversion program for adult community members who have been engaged with the criminal justice system in Fairfax and Loudoun County, Virginia.	Fairfax County VA	\$742
Loudoun County	This project is a three-year, phased implementation of additional body-worn camera units, associated licenses, training, network infrastructure, data storage, and personnel for the Loudoun County Sheriff's Office. The impact of additional body-worn camera units also necessitates the need for additional staff to support the Loudoun County Commonwealth's Attorney's Office to address increased evidence.	Loudoun County VA	\$3,587
Virginia Polytechnic Institute and State Universit	Funding will allow Virginia Tech fisheries research to provide additional data, insight, and information on annual flounder supply. Additional scientific information will enable the Mid-Atlantic Fisheries Management Council to make the best-informed decisions on quota and thus provide more stability in the flounder industry from year to year. Due to global climate change, shifts in flounder populations, and other complicating factors, gauging an appropriate quota has become increasingly more complex, leading to instability in the valuable seafood crop from season to season.
