The Paycheck Protection Program and Health Care Enhancement Act

On April 23rd, Congress passed the Paycheck Protection Program and Health Care Enhancement Act, H.R. 266. This bill replenishes the PPP, providing an additional \$321 billion for the program. The bill sets aside \$60 billion for loans made by small and mid-sized banks and credit unions as well as community-based lending institutions, with the goal of reaching underbanked businesses such as rural businesses and women- and minority-owned businesses.

\$30 billion will be dedicated to community-based lenders, including Community Development Financial Institutions (CDFIs), Minority Depository Institutions, SBA microlenders, and certified development companies/SBA 504 lenders. Below is a list of these Virginia lending institutions that qualify for the set-aside in H.R. 266.
