## A BILL

To allow veterans to use, possess, or transport medical marijuana and to discuss the use of medical marijuana with a physician of the Department of Veterans Affairs as authorized by a State or Indian Tribe, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Medical
- 5 Marijuana Safe Harbor Act.".

## 1 SEC. 2. FINDINGS.

2 Congress finds the following:

- (1) Chronic pain affects the veteran population, with almost 60 percent of veterans returning from serving in the Armed Forces in the Middle East, and more than 50 percent of older veterans, who are using the health care system of the Department of Veterans Affairs living with some form of chronic pain.
  - (2) In 2020, opioids accounted for approximately 75 percent of all drug overdose deaths in the United States.
  - (3) Veterans are twice as likely to die from opioid related overdoses than nonveterans.
  - (4) States with recreational cannabis laws experienced a 7.6 percent reduction in opioid-related emergency department visits during the 180-day period after the implementation of such laws.
  - (5) Marijuana and its compounds show promise for pain management and treating a wide-range of diseases and disorders, including post-traumatic stress disorder.
  - (6) Medical marijuana in States where it is legal may serve as a less harmful alternative to opioids in treating veterans.

- 3 (a) SAFE HARBOR.—Notwithstanding the Controlled
- 4 Substances Act (21 U.S.C. 801 et seq.), the Controlled

22	SEC. 4. RESEARCH ON USE OF MEDICAL MARIJUANA BY
23	VETERANS.
24	(a) Research on Effects of Medical Mari-
25	JUANA ON VETERANS.—

1	(1) In general.—Not later than 180 days
2	after the date of the enactment of this Act, the Sec-
3	retary of Veterans Affairs shall support clinical re-
4	search on the use of medical marijuana—
5	(A) by veterans to manage pain; and
6	(B) for the treatment of veterans for dis-
7	eases and disorders such as post-traumatic
8	stress disorder.
9	(2) Interagency coordination.—The Sec-
10	retary shall coordinate and collaborate with other
11	relevant Federal agencies to support and facilitate
12	clinical research under paragraph (1).
13	(3) Report.—Not later than two years after
14	the date of the enactment of this Act, the Secretary
15	shall submit to Congress a report on the ongoing
16	clinical research supported by the Secretary under
17	paragraph (1), which shall include such rec-
18	ommendations for legislative or administrative action
19	as the Secretary considers appropriate to continue to
20	support the management of pain and the treatment
21	of diseases and disorders of veterans.
22	(b) STUDY ON USE BY VETERANS OF STATE MED-
23	ICAL MARIJUANA PROGRAMS.—
24	(1) In general.—Not later than two years
25	after the date of the enactment of this Act, the Sec-

retary shall conduct a study on the relationship between treatment programs involving medical marijuana that are approved by States, the access of veterans to such programs, and a reduction in opioid use and misuse among veterans.

- (2) Report.—Not later than 180 days after the date on which the study required under paragraph (1) is completed, the Secretary shall submit to Congress a report on the study, which shall include such recommendations for legislative or administrative action as the Secretary considers appropriate.
- 12 (c) VETERAN DEFINED.—In this section, the term 13 "veteran" has the meaning given that term in section 101 14 of title 38, United States Code.
- 15 (d) AUTHORIZATION OF APPROPRIATIONS.—There 16 are authorized to be appropriated to the Secretary of Vet-17 erans Affairs such sums as may be necessary to carry out 18 this section.
