

2022 Congressionally Designated Spending Dollars for Central Virginia



U.S. Senators Mark R. Warner and Tim Kaine

- **Following Warner's request, \$5,805,000** is headed to the **Virginia National Guard** to assist with the planning and design for a relocated Virginia National Guard Army Aviation Support Facility (AASF) in **Sandston**.
- **Following Warner and Kaine's joint request, \$5,000,000** is headed to **Richmond** to help cover the design, engineering, construction, and inspection costs associated with the rehabilitation of Mayo Bridge, which was identified as structurally deficient by the latest Bridge Safety Inspection Reports. This project will help preserve Richmond's oldest surviving highway bridge across the James River.
- **Following Warner and Kaine's joint request, \$3,969,000** is headed to **Richmond** to conduct a Federal Inspection Service Facility Renovation Project at the Richmond International Airport. This project will renovate the existing Federal Inspection Service Facility, which was built in 2003 and does not meet current Customs and Border Protection Service Facility requirements. The renovation will allow the airport to provide non-stop, scheduled international flights to and from Richmond.
- **Following Warner and Kaine's joint request, \$2,000,000** is headed to **Petersburg** to fund the southernmost portion of the Fall Line Trail, starting in Petersburg and through Virginia State University's campus.
- **Following Kaine's request, \$1,015,000** is headed to **Albemarle** to help support Greater Charlottesville's Habitat for Humanity Chapter as it redevelops the Southwood Mobile Home Park into a mixed income, mixed-use neighborhood.
- **Following Warner and Kaine's joint request, \$1,000,000** is headed to **Henrico County** to help with the design and construction of a 24-hour center that will provide inpatient detox services. The proposed center will guide people into recovery in a way that better serves the individual, reduces crime in the community, diverts individuals from the criminal justice system, and better supports overall public safety.
- **Following Warner and Kaine's joint request, \$1,000,000** is headed to **Chesterfield County** to fund planning and environmental review for a road drainage improvement project aimed at alleviating routine flooding that occurs at the crossings along Otterdale Road in Chesterfield County.
- **Following Warner's request, \$1,000,000** is headed to the **City of Richmond's** Southside Parks and Workforce Development Project, which will help improve job opportunities and community quality of life by providing five public, accessible, community-envisioned greenspaces in areas of South Richmond that don't currently have walkable access to parks.

- **Following Warner and Kaine’s joint request, \$1,000,000** is headed to **Chesterfield County** to fund a project to enhance access to the Ettrick train station by providing bike and pedestrian accommodations, improved safety features, and Americans with Disabilities Act (ADA) compliance, and executing intersection upgrades to create a more efficient access and egress.
- **Following Warner and Kaine’s joint request, \$966,000** is headed to **Richmond** for Virginia Commonwealth University’s gun violence prevention framework. The framework will serve as a public health response to the underlying social and economic factors that promote gun violence in the City of Richmond.
- **Following Warner and Kaine’s joint request, \$500,000** is headed to **Prince Edward County** to support Longwood University as it makes needed upgrades to the Robert Russa Moton Museum, a National Historic Landmark. This funding will upgrade the museum’s heating, ventilation, and air conditioning (HVAC) system, which is almost two decades old and functions inconsistently.
- **Following Warner and Kaine’s joint request, \$488,000** is headed to **Richmond** to help fund the Virginia Hospital-Based Violence Intervention Program Collaborative, which focuses on serving patients who need treatment for gunshot wounds, stabbings, or assault, as well as sexual and domestic violence.
- **Following Warner and Kaine’s joint request, \$400,000** is headed to **Richmond** to help fund Virginia Commonwealth University’s teacher residency program, which will launch a new pipeline to recruit, support, train, and retain high quality early childhood teachers in Central Virginia public schools. Senator Kaine’s [PREP Act](#) encourages school districts to create partnerships, including teacher residency programs, with local community colleges and universities to ensure their programs are educating future teachers in areas where there is a shortage of educators.
